Some of the resources available to Florida Bar members include:

A member profile which allows you to conduct all of your bar transactions online, such as paying annual fees, registering for Continuing Legal Education and managing your CLE account, listing your current contact information for anyone using the Find A Lawyer function on the bar website, and accessing free legal research.

Free legal research - the Florida Bar offers free access to [Fastcase](#) which covers Florida case law. Additional jurisdictions may be added for a discounted fee.

Discounts are available for insurance (life, health, professional liability), research, business services, and travel.

Law Office Management Assistance (LOMAS) provides forms, checklists, advice, guidance, articles and other resources to help you manage your law office.

Ethics Opinions are available on the bar website. The database is searchable by opinion number or keyword. There are also: a list of opinions by opinion number, a subject matter index to the opinions, a FAQ sheet, information packets, proposed advisory opinions, and a link to the Florida Bar Ethics Hotline.

The Florida Bar News and Journal – print versions are mailed out to bar members but the Florida Bar News is also available online and includes items such as articles on current legal events in the state, job listings, and the Lawyer’s Marketplace.
