Endnotes should follow the most recent version of the *ALWD Citation Manual: A Professional System of Citation*, published by Aspen Publishers. The *Review* will conform all manuscripts selected for publication to *The Redbook: A Manual on Legal Style*, published by West.

The *Review* assumes no responsibility for the return of manuscripts. Although the *Stetson Law Review* generally grants great deference to an author's work, the *Review* retains the right to determine the final published form of every article.
