



Outstanding Financial Obligations

The College of Law will withhold diplomas, certificates, and transcripts, and will withhold registration for additional semesters, until all financial obligations are met or until the student or graduate has entered into an approved payment plan with the College of Law. If a diploma, certificate, transcript, or registration is withheld because of an unpaid bill, a student or graduate will be required to use a certified check, money order, or cash to release these documents.
